- SDNP/21/05037/TCA - The Old Vicarage, Vicarage Lane, Hambleton, Waterlooville, Hampshire, PO7 4RP. Two beech trees on the edge of the property have been inspected and are leaning over the flint stone wall onto the neighbouring garden and over the public footpath. The tree is leaning and cracking the wall. It is also dangerous to the public and school children using the pathway. The roots of the tree are visible and lifting out of the ground. The trunk and crown condition are both good. The probability of tree failure is high. Recommended advise is for a complete remove due to health & safety reasons.
