2846. Planning Applications

- SDNP/25/04323/TCA T1 - The Cross Tree, West Street, Hambledon, Hampshire, PO7 4SN. Tulip - reduce lateral branches growing towards property by 1.5m back to suitable growth points to maintain clearance

from dwelling and facilitate new building extension. Crown raise canopy to 2.5m. T2 - Fig - reduce height of by up to 1m. Reduce spread by up to 1.5m to maintain size and root growth as close proximity to boundary wall.

- SDNP/25/03338/FUL - The Vineyard, East Street, Hambledon, Hampshire, PO7 4RY. Change of use of Mill Down House from residential (Use Class C3) to business use (Use Class E(g)(i) with ancillary short-stay accommodation for staff and vineyard / winery workers. [APPROVED.]
