I am forwarding this because of the disruption it will cause to traffic flow in the midst of the Meon Valley Division.

Dear Councillor Huxstep,

Further to my email dated 1<sup>st</sup> April 2020, this is to advise you that we will shortly be undertaking the footway improvement works on High Street, Shirrell Heath, from Gamblins Lane (outside Mount Pleasant) to Solomans Lane (outside Trelawney), north side only.

The works are programmed to start on 21<sup>st</sup> September 2020 and are expected to last for 11 weeks. During which time the road will be closed to vehicular traffic, between the hours of 09:30 – 16:00hrs. The road will be open during the evenings and weekends.

Due to the current COVID-19 situation, works will be carried out ensuring safe working practices, and social distancing between site operatives and members of the public are maintained at all times. The appropriate traffic management will be in place to prevent any interaction.

Information signs advising road users of the works will be erected before the start of works. A letter will be sent to local residents and an email will be sent to Winchester City Council and Shedfield Parish Council to advise them accordingly

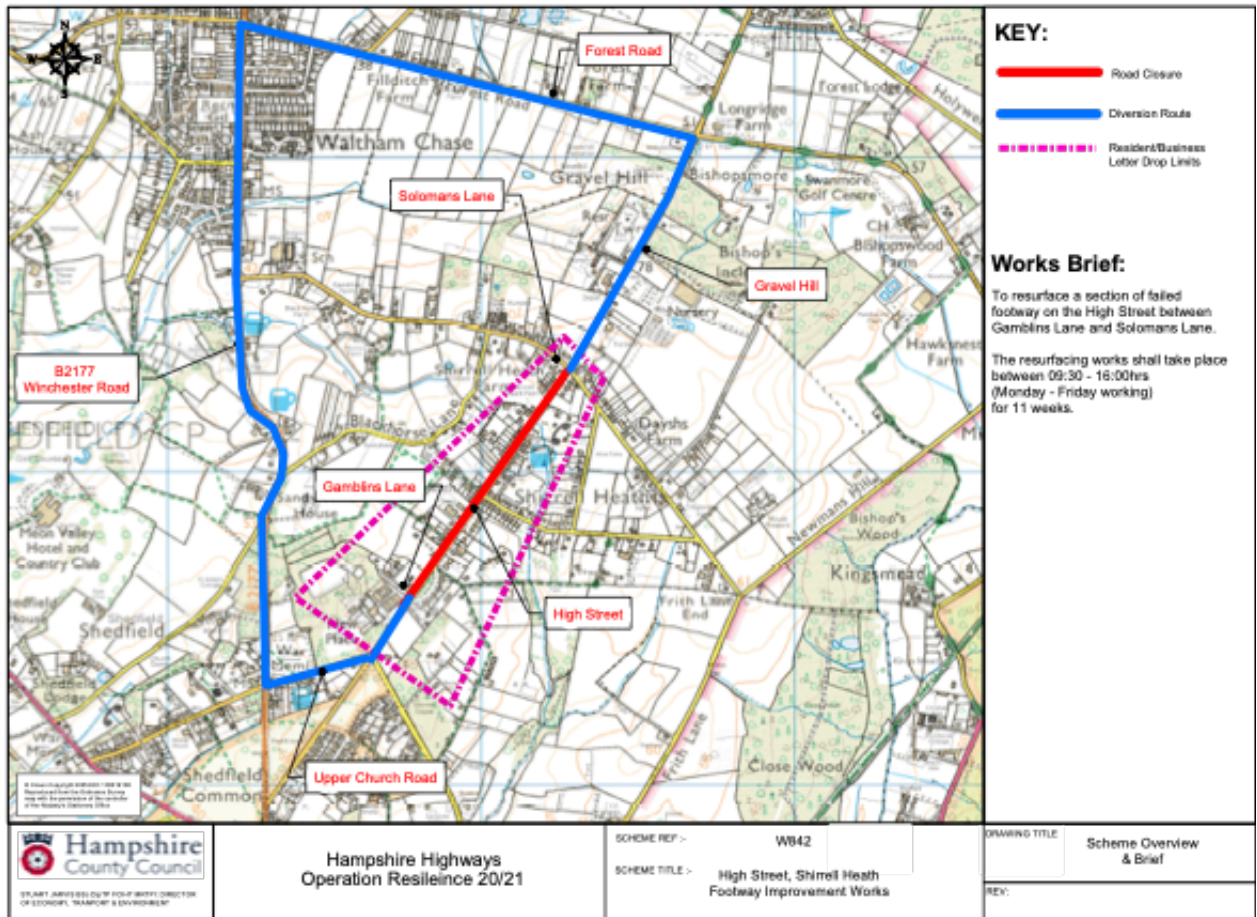
