

## Local context

### Local Covid-19 data

The County Council will today (9 November) [publish](#) the latest weekly Covid-19 data dashboard. The data shows a total number of cases in Hampshire of 12,426 since March 2020 and 1,714 cases confirmed in the last seven days, which is an increase of 132.

The county's current weekly case rate stands at 123.7 per 100,000 population, which is below the England case rate at 243.2.

There have been 1,091 Covid-19 associated deaths in Hampshire since March, and 8 deaths in the last seven days.

### School attendance

High attendance levels at primary and secondary schools in Hampshire have continued into the second half of the autumn term, despite the number of cases of Covid-19 rising across the county. Early years settings are similarly reporting that the number of children in attendance has been steadily increasing since the beginning of the autumn term.

In the [press release](#), the Executive Member for Education and Skills, Councillor Roz Chadd, is quoted: "To maintain this stability, and to #KeepHampshireSafe, it is vitally important that we all continue to follow the new national guidance to continue social distancing, minimise social contact and avoid mixing with other households, as well as regular handwashing."

### National restrictions

The County Council continues to help build Hampshire residents' awareness of the national restrictions which began on 5 November. A new short and informative [animation](#) has been produced to clarify the guidance around national restrictions. It has been promoted widely on the County Council's social media channels and has been well received.

The County Council is also promoting a [poster](#) which can be displayed within local communities to further advertise the support that is available to any resident in need during this time.

## National context

### Communities

#### **Jobcentre guidance**

The Department for Work and Pensions (DWP) has [issued](#) new jobcentre guidance. They have confirmed that jobcentres will remain open in line with the latest government and Public Health England guidance, however customers will also be supported by Work Coaches online and over the phone. Face-to-face assessments for disability benefits remain suspended.

#### **Court and tribunal response and recovery**

HM Courts and Tribunals Service has [published](#) an update outlining the work undertaken in their response to and planned recovery from the Covid-19 pandemic.

### Children and education

#### **Winter support package for vulnerable children and families**

The Government has [announced](#) additional support for vulnerable children and families over the winter, which includes:

- £170m Covid Winter Grant Scheme - ring-fenced funding will be distributed to councils at the start of December, with at least 80% earmarked to support with food and bills. It will cover the period to the end of March 2021
- Holiday Activities and Food programme to be expanded, covering Easter, Summer and Christmas in 2021

- Healthy Start payments set to rise from £3.10 to £4.25 a week from April 2021
- Pledged additional funding of £16m to food distribution charities

### **Childcare bubbles**

The Department of Health and Social Care (DHSC) has [published](#) guidance on informal childcare bubbles. This allows friends or family from one other household to provide informal childcare for children aged 13 or under.

### **NHS COVID-19 app in education and childcare settings**

The Government has [updated](#) the guidance on the use of the NHS Covid-19 app in education and childcare settings.

## **Adults' social care and public health**

### **Vaccine**

A Covid-19 vaccine developed by U.S. pharmaceuticals company Pfizer and Germany's BioNTech is more than 90 percent effective, according to the first look at data from a late-stage trial involving nearly 44,000 participants. An analysis of 94 trial participants who contracted Covid-19 showed that the vaccine was 94 percent effective, Pfizer and BioNTech said in a [press release](#) today.

### **Reducing vaccine disinformation**

The Government has [announced](#) that they have agreed with social media platforms new measures to limit the spread of vaccine misinformation and disinformation. Facebook, Twitter and Google have committed to the principle that no company should profit from or promote Covid-19 anti-vaccine disinformation, to respond to flagged content more swiftly, and to work with authorities to promote scientifically accurate messages.

## **Economy, business and finance**

### **Bounce Back Loan Scheme (BBLs)**

The guidance on BBLs has been [updated](#) with information on the new options available to top up existing loans, extend the loan period, make interest-only repayments, or pause repayments.

## **Environment, transport and travel**

### **Freight from Denmark**

The Department for Transport has [announced](#) that they have extended measures to prevent the potential spread of a variant strain of Covid-19 (resulting from minks). The freight exemption has been removed so UK haulage drivers arriving from Denmark are now required to self-isolate on entry to England. In addition, the exemption for non-UK resident freight drivers is removed so those who have travelled from or through Denmark in the last 14 days can no longer enter UK and passenger planes and ships travelling directly from Denmark, and accompanied freight, will no longer be able to land or dock at English ports.

## **National Covid-19 data**

As of 4pm on 9 November, the total number of people tested positive for Covid-19 was **1,192,013** and daily number of lab-confirmed cases was **20,572**. The total number of Covid-19 associated deaths within 28 days of a positive test was **49,044**, with **156** deaths reported on the day. The data is available to [view online](#).

The R number range for the UK is **1.1-1.3** and the growth rate range is **+2% to +4%** per day as of 6 November.
